



- Flange and display are 300-series stainless steel.
- R513A refrigerant is non-flammable and has low-globalwarming-potential (GWP).
- · Frost-top display area is one-piece.








VENTING REQUIREMENTS

One customer-supplied intake and one discharge louver (two total) must be installed in the cabinet to ensure adequate ventilation; preferred locations are short ends.
